

Dear Sir,

This has reference to the letter No. IV(16)21/GST Cell/Tech/BPL/17-18/Pt.I dated 06.09.2017 (copy enclosed) received from the Joint Commissioner (Tech), CGST, Customs & Central Excise, Bhopal. In this connection, I am to convey the provisions contained in para 3 of the above referred letter & which reads as "the activity of Testing, Caliberation, safety check or certification related to protection or safety of workers, consumers or public at large, including fire licence, required under any law for the time being in force provided by the said Institute is exempted from the levibility of GST".

Further as regards to the submission of payment of test fees of the machines, you are kindly requested to submit the payment of test fees online on the portal <https://bharatkosh.gov.in> and a receipt so generated should be submitted to this Institute as a proof of payment. 
