6.4 Salient Observations:

6.4.1 Laboratory tests:

6.4.1.1 Hydraulic Performance:

During the lifting capacity test at couple frame, the angle of rotation of mast was observed **1.1** degree over the full range of lift against the minimum requirement 10 degree. This should be looked into for necessary corrective action.

6.4.1.2 Operator's seat:

The following parameters does not meet the requirement of IS: 12343-2021:

- (i) Provision for adjustment of driver's mass has been specified as 50 to 120 kg against the requirement of 40 to 100 kg as per of IS: 12343-2021. This should be looked into for necessary corrective action.
- (ii) Vertical distance from SIP to center line of steering control wheel has been measured as 250 mm against the requirement of 265 to 385 mm.
- (iii) Height of foot step from ground level has been measured as 605 mm against the maximum requirement of 550 mm.

Therefore, all of the above should be looked into for necessary corrective action.

6.4.1.3 Three-point linkage:

The dimensions viz. diameter of width of ball of upper hitch points, lateral distance from lower hitch point to centre line of tractor & power range does not meet the requirements of IS: 17231-2019. This should be looked into for corrective action.

6.4.1.4 Operator's work place:

Operator's work place meets the requirements of IS: 12239 (Part-I) 2018, except the following:

- (i) Provision of vertical retainers at inner sides of clutch pedal.
- (ii) Provision of spark arresting device in the exhaust system.

Therefore, all of the above should be looked into for necessary corrective action.

6.4.1.5 PTO master shield:

PTO master shield has not been provided on tractor as per IS: 12239-1999 (Part-2). This should be looked into for necessary corrective action.

6.5 Maintenance / Service Problems:

No noticeable maintenance or service problem was observed during the test.

6.6 Recommendation with regard to safety on tractor:

The following requirements, inter alia, may be considered for incorporation on the tractor:

- i) Identification of control lever by colour has not been provided as per the requirement as laid down in Table 5 of IS: 8133-2021.
- ii) The hand accelerator lever, when moved away from the operator (i.e., forward) decreases the engine speed, which does not meet the requirement as laid down in Table 1 of IS: 8133-2021.
- iii) The distance between engine stop control and start control was measured 350 mm against the maximum requirement of 150 mm.
- iv) Fuel shutoff knob does not remain in stop position as per the requirement of IS: 8133-2021.

- v) Colour codes of engine revaluation gauge has not been provided as per the requirement as laid down in IS: 6283 (Part 2): 2007 (Reaffirmed year 2019).
- vi) The working clearance between draft control lever and LHS mudguard has been measured as 25 mm against the minimum requirement of 70 mm as per the requirement of IS: 12239 (Part II) 2019

All of the above should be looked into for necessary corrective action.

- **6.7.1** Literature was supplied with the tractor for reference during the test.
 - a) Operator's manual for "International Tractors Ltd., DI-55 III" tractors model.
 - b) Part's catalogue for "International Tractors Ltd., DI-55 III" tractors model.
 - c) Service manual for "International Tractors Ltd., DI-55 III" tractors model.
- The operator manual may be brought out for the guidance of users and service personnel as per IS:8132-1999 incorporating, inter alia, the following:
 - i) Engine to PTO speed ratio
 - ii) Recommended grade of coolant & coolant water ratio
 - iii) Detail of multispeed PTO
