#### 6.4 Salient Observations:

#### 6.4.1 Laboratory tests:

#### 6.4.1.1 Three-point linkage:

The following parameters does not meet the requirements of IS: 4468 (Part-I) – 1997 and needs to be looked into for necessary corrective actions:

i) The dimensions viz. width of ball of upper hitch point does not meet the requirements of IS: 17231-2019. This should be looked into for corrective action.

#### 6.4.1.2 Operator's seat:

The following parameters do not meet the requirement of IS: 12343-2021.

- i) Provision for adjustment of driver's mass has been specified as 50 to 120 kg against the requirement of 40 to 100 kg.
- ii) Vertical distance from SIP to centre of accelerator pedal has been measured as 490 mm against the requirement of 230 to 460 mm.
- iii) Vertical distance from SIP to centre of steering control wheel has been measures as 190 mm against the requirement of 265 to 385 mm.
- iv) Vertical distance from SIP to foot rest has been measured as 570 mm against the requirement of 450 to 520 mm.

Therefore, all of the above parameters should be looked into for necessary corrective action.

#### 6.4.1.3 Operator's work place:

The following parameters does not meet the requirement of IS: 12239 (Part-I) -2018.

- i) A vertical retainness on inner side of clutch & brake pedal has not been provided.
- ii) Spark arresting device has not been provided in the exhaust system.

Therefore, all of the above should be looked into for necessary corrective action.

#### 6.4.1.4 PTO master shield:

PTO master shield has not been provided on tractor. This should be looked into for necessary corrective action.

#### 6.4.1.5 Specification of Tractor

### 6.5 Maintenance / Service Problems:

No noticeable maintenance or service problem was observed during the test.

#### 6.6 Recommendation with regard to safety on tractor:

- i) Identification of differential lock by color has not been provided as per the requirement as laid down in Table 5 of IS: 8133-2021.
- The hand accelerator lever, when moved away from the operator (i.e. forward) decreases the engine speed, which does not meet the requirement as laid down in Table - 1 of IS: 8133-2021.
- iii) Color code on illuminated display has not been provided as per the requirement as laid down in IS: 6283 (Part 2): 2007.

Above parameters should be looked into for necessary corrective action.

- **6.7.1** The following literatures were supplied with the test tractor for reference during the test:
  - a) Operator's Manual for "New Holland, 3630 TX + UG A5, 3630 TX Plus+ UG 4WD A6, 3630 TX Plus+ A7 and 3630TX Plus+ 4WD A8" tractor models.
  - b) Parts catalogue for "New Holland, 3630TX Plus+ UG 4WD A6" tractor model.
  - c) Service manual for "New Holland, 3630 TX + UG A5, 3630 TX Plus+ UG 4WD A6, 3630 TX Plus+ A7, 3630 TX A7 and 3630TX Plus+ 4WD A8" tractor models.
