6.4 Salient Observations:

6.4.1 Operator's seat:

The following parameters do not meet the requirement of IS: 12343-2021.

- i) Provision for adjustment of driver's mass has been specified as 50 to 120 kg against the requirement of 40 to 100 kg.
- ii) Vertical distance of SIP from footrest has been measured as 580 mm against the requirement of 450 to 520 mm.

This should be looked into for necessary corrective action.

6.4.2 Operator's work place:

The following parameters does not meet the requirement of IS: 12239 (Part-I) 2018.

- i) Vertical retainers on inner side of clutch pedal are not provided.
- ii) Spark arresting device has not been provided in the exhaust system.

This should be looked into for necessary corrective action.

6.4.3 Three-point linkage:

The dimensions viz. diameter of hitch pin hole & width of ball of upper hitch points & diameter of hitch pin hole of lower hitch points does not meet the requirements of IS: 17321-2019. This should be looked into for corrective action.

6.4.4 Dimensions of PTO shaft:

PTO shaft height was measured 700 mm from ground level against the requirement of 450 to 675 mm, which does not meet the non-evaluative requirements of IS 4931-1995. This should be looked into for corrective action.

6.4.5 Specification of Tractor

i) Discrepancies in the specification between the Specification sheet and Operator's manual are as under:

ii) Power of generator is given as 60 A in the technical specification submitted by applicant, whereas power should be mentioned in kW.This should be looked into for necessary corrective action.

6.5 Maintenance / Service Problems:

No noticeable maintenance or service problem was observed during the test.

6.6 Recommendation with regard to safety on tractor:

i) Colour codes of engine revolution gauge has not been provided as per the requirement as laid down in IS: 6283 (Part 2): 2007 (Reaffirmed year 2019).

Above parameters should be looked into for necessary corrective action.
