6.4 Salient Observations:

6.4.1 Dimension of Three Point Linkage:

The power range (without force) has been measured as 640 mm against the requirement of 650 mm, which does not meet the requirements of IS: 17231:2019 and needs to be looked into for necessary corrective actions:.

6.4.2 Operator's seat:

The following parameters does not meet the requirement of IS: 12343-2021:

- i) Provision for adjustment of driver's mass has been specified as 50 to 120 kg against the requirement of 40 to 100 kg.
- ii) Vertical distance of SIP from accelerator pedal has been measured as 540 mm against the requirement of 230 to 460 mm.
- iii) Vertical distance of SIP from foot rest has been measured as 590 mm against the requirement of 450 to 520 mm.
- iv) Vertical distance of SIP from centre of steering control wheel has been measured as 255 mm against the requirement of 265 to 385 mm.

Therefore, all of the above should be looked into for necessary corrective action.

6.4.3 Operator's work place:

The following parameters does not meet the requirement of IS: 12239 (Part-I) 2018.

- i) Vertical retainers on inner side of clutch and brake pedals have not been provided.
- ii) Spark arresting device has not been provided in the exhaust system.

Therefore, all of the above should be looked into for necessary corrective action.

6.4.4 PTO master shield:

PTO master shield has not been provided on tractor as per IS: 12239-1999 (Part-2). This should be looked into for necessary corrective action.

6.5 Maintenance / Service Problems:

No noticeable maintenance or service problem was observed during the test.

6.6 Recommendation with regard to safety on tractor:

- Colour codes on illuminated display has not been provided as per the requirement as laid down in IS: 6283 (Part 2): 2007.
- ii) Identification of differential lock pedal & PTO engage lever by colour has not been provided as per the requirement as laid down in Table 5 of IS: 8133-2021.
- iii) Fuel shutoff knob does not remain in stop position as per the requirement of IS: 8133-2021.
- iv) The working clearance between draft control lever & position control lever has been measured as 50 mm against the minimum requirement of 70 mm as per the requirement of IS: 12239 (Part II) - 2019

Above parameters should be looked into for necessary corrective action.

- 6.7.1 The following literatures were supplied with the test tractor for reference during the test:
 - a) Operator Manual for "New Holland 3600-2 A, 3600-2 A1, 3600-2 A2, 3600-2 A3, 3600-2 A5, 4710 E, 4710 E1, 4710 E2, 4710 E3, 4710 E4 & 4710 E5" tractor models.
 - b) Parts catalogue for "New Holland 3600-2 A" tractor model.
 - c) Service manual Part I, II & III for "New Holland 3600-2 A5, 3600-2 A, 3600 & 4710 E" tractor models.
- 6.7.2 The operator manual may be brought out for the guidance of users and service personnel as per IS: 8132-1999 incorporating, inter alia, the following:
