

1	Tender must be submitted in the prescribed tender form, downloaded from Institute's website: <a href="http://www.fmttibudni.gov.in">www.fmttibudni.gov.in</a> , at CFMTTI, Tractor Nagar, Budni, M.P. on any working day (Mon to Fri) from <b>05.12.2022</b> .
2	Duly filled tender form accompanied by all required documents namely, (a) demand draft of <b>Rs. 500/- (Non-refundable) as fee for application form</b> , drawn in favour of Director, Central Farm Machinery Training & Testing Institute, Tractor Nagar, Budni, M.P.-466445, <b>Payable at SBI Branch, IFSC Code SBIN0000383, Hoshangabad, M.P.</b> (b) Demand Draft of Rs. 10,000/- as bid security. (c) Self-attested copy of PAN Card. (d) Self-attested copy of Aadhaar card. (e) All the above must reach at this office latest by <b>20.12.2022 (10:30 AM)</b> .
3	Sealed tenders will be opened on the same day i.e. <b>20.12.2022 at 11.00 AM</b> , in the Auditorium hall of CFMTTI, Budni-466445, M.P.
4	(i) Every tenderer must deposit <b>demand draft of Rs. 10,000/- (Ten thousand only) as bid security</b> , to participate in tender auction, in the form of a Demand Draft, drawn in favour of the Director, CFMT&TI, Budni, M.P., payable at SBI Branch, IFSC Code SBIN0000383, Hoshangabad, (M.P). <b>The tender will not be considered if the bid security is not deposited along with tender.</b> Date of Demand Draft should be drawn after the issue of the advertisement clearly indicated in the form. (ii) The tenderer/bidder should append his signature on the tender form, without which the bid is liable to be rejected.

5	The successful bidder shall be required to deposit <b>50% of the bid amount offered, immediately/on the same day, latest by 05:30 PM</b> by online payment on NTRP (BHARATKOSH) Portal, <b>failing which, bid offered shall be rejected and bid security shall stand forfeited. 9	The empty/blank tender box for the tender invitation/submission purpose will be sealed by the committee on <b>06.12.2022 at 10:00AM.</b>
10	Tenderer should submit tender form in a sealed cover, marked " <b>Tender for AMBASSADOR CAR</b> ". The duly filled tender form must reach this institute latest by <b>20.12.2022 (10:30AM)</b> . Institute will not be responsible for any postal delay or delay due to any reasons.
11	<b>OPENING OF TENDER:</b> Bidders/tenderer are at liberty to be present himself/themselves or authorize a representative to be present at the time of bid/opening of tender. <b>(One person only)</b>
12	The bidder must ensure that he meets all the statutory/legal/ administrative requirements, as required by the Government, to participate in such bidding and to collect all those items which he has acquired from the auction.
13	The successful bidder shall lift/take away the sold vehicle only on working day (Monday to Friday) from <b>9:00AM to 5:00PM</b> latest by <b>26.12.2022</b> , otherwise ground rent, as per prevailing rate, shall be levied. It is to clarify that under any circumstances lifting/take away the auctioned vehicle will not be allowed unless full amount of bid is deposited in the office.
14	Lifting/take away the vehicle will be allowed under the supervision of store in-charge/supervisor during working days.
15	The GST as applicable on date @ 18% (subject to revision by competent authority), Tax collected at source if and as applicable shall have to be deposited by the successful bidder separately and immediately.
