1. In order to popularize the use of Agricultural Drone among the farmers, the Institute invites the "Expression of Interest" for **Demonstration of use of Agricultural Drone in the Farmer's Field** from the interested firm.
2. The quotation must reach the Institute on or before 14.04.2023

The Institute offers following basic facilities:

1. Hostel of sufficient capacity for staying of pilots, co-pilot and may be available if empty.
2. A co-operative mess for breakfast, lunch and dinner which is payable at nominal rate.

Scope of work:

1. Tentatively, the firm shall have to conduct two demonstrations every month. However, this is subject to change at the discretion of the Institute.
2. The said contract will be up to 31.03.2024
3. Each demonstration shall cover at least 1 hectare of area.

Terms and conditions:

1. It shall be the sole responsibility of the firm to ensure that their pilot / co-pilot whom the depute for demonstration posses the entire statutory requirement.
2. The site as well as the date of demonstration shall be decided by the Institute.
3. It shall be the responsibility of the firm to ensure that demonstration is successfully conducted on the schedule date and site.
4. In order to ensure the uninterrupted demonstration, the firm shall remain sets of adequate number of batteries which, in any case, should not be less than six.
5. In order to handle any major breakdown or other problems, the firm shall be equipped with standby equipment also.
6. It shall be the responsibility of the bidder to ensure that it complies with all the rules / regulations applicable as on date.
7. The payment shall be made only after successful demonstration of agricultural drone
8. If the firm fails to conduct the programme as per the schedule, the work order awarded to him shall stand cancelled. Also the institute shall be free to take any official / legal action against the erring firm.
9. The bidder shall quote the rate on per hectare basis and shall remain valid up to 31.03.2024.
