**OFFICE MEMORANDUM**

**Subject:- Display/Disclosure of reservation roster - regarding**

The undersigned is directed to say that DoPT, vide OM No.43038/2/3/92-Estt.(SCT) dated 31.12.1992, has informed all the Ministries/Departments that the reservation roster is not a confidential document and there can be no objection to the roster being shown to any individual/association. Further, the said OM also provides that if any Government Servant/Recognized Service Association wants to see the reservation roster, there can be no objection to the roster being shown to them, if need be, through the Liaison Officer.

2. In this regard, it is stated that the National Commission for Scheduled Tribes (NCST) has informed DoPT that the concerned administrative authorities, at times, do not disclose or share the reservation rosters with the concerned employees. Hence, NCST has recommended that the instructions regarding disclosing of reservation rosters may again be reiterated to all the Ministries/Departments.

3. In view of the above, all the Ministries/Departments are requested to direct the administrative authorities under their control that if any of its employees or recognized service association requests or demands for disclosure/production of reservation roster, the same should be provided forthwith.
