

6.1 Evaluative (mandatory) / Non-evaluation (Non-mandatory) parameter applicable for qualifying Minimum Performance criteria as per Clause-4 (Table-1) of IS: 12207-2014 for acceptance of the tractor for the purpose of subsidies/NABARD financing are summarized as under:

#### 6.3 Salient Observations:

#### 6.3.1 Laboratory tests:

#### 6.3.1.1 PTO Performance:

- The maximum power in case of previous & present sample was observed as 10.5 kW & 10.2 kW respectively against the declaration of 10.3 kW which is within the tolerance limit specified in IS: 12207-2014.
- The specific fuel consumption corresponding to maximum power in case of previous & present sample was observed as 327 g/kWh & 339 g/kWh respectively against the declaration of 323 g/kWh which is within the tolerance limit specified in IS: 12207-2014. This is considered on higher side for this power range of tractor.

#### 6.3.1.2 Three point linkage:

The following dimensions of three point linkage does not meet the requirement of IS: 4468 (Part-2) -1993. This should be looked into for necessary corrective action.

- The diameter of hitch pin hole of upper hitch points.
- Distance from end of power take-off shaft to centre of lower hitch point (lower links in horizontal position).
- iii) Transport height, power / movement range and leveling adjustment range.
- iv) Some of the parameters of three point linkage conform to Category-I N and some of them conform to Category-I. In view of the spirit of standardization, necessary improvement may be incorporated.

#### 6.3.1.3 Linkage drawbar:

Dimension "DØ" (Refer Fig.1) of linkage drawbar does not meet the requirement of IS: 12953-1990. This should be looked into for necessary corrective action.

#### 6.3.1.4 Specifications of Power Take-off Shaft:

The dimension "dØ" (See Fig. 2) of PTO shaft does not meet the requirement of IS: 4931:1995, this should be looked into for compliance.

#### 6.3.1.3 Operator's Seat:

- i) The width of operator's seat was observed as 400 mm against the requirement of 450 (minimum)' mm as per IS: 12343-1998. This should be looked into for necessary corrective action.
- ii) Longitudinal adjustment forward and rearward from the mid position.

#### 6.3.2 Field Performance:

#### 6.3.2.1 Wet land cultivation (Puddling operation) :-

There is no ingress of water and /or mud was observed after the wetland operation at specified assemblies as per IS: 11082:1982. Therefore, the tractor is considered suitable for wetland cultivation (Puddling operation).

#### 6.4 Recommendation with regard to safety on tractor:

The following requirements, inter alia, may be considered for incorporation on the tractor:

- Provision of safety against accidental start of engine.
- ii) Provision of spark arresting device in the exhaust system.
- iii) Provision for Master shield for PTO shaft.
- iv) Provision of front tow hook.
- v) The working clearance between the high-low range shifting lever engage in high position and bottom of seat base has does not meet the requirement of the IS: 12239 (Part-2)-1996. This should be looked into for necessary corrective action.
- vi) Symbols for engine oil pressure gauge, grease lubricant frequency ,oil lubricant ,type and frequency & color code for engine oil pressure gauge may be provide as per requirements of IS:6283 (Part I & II) 1998.
