## 7.2 Salient Observations:

# 7.2.1 Laboratory tests:

## 7.2.1.1 PTO Performance:

i) The specific fuel consumption corresponding to maximum power was measured as **249** g/kWh against the declaration of 265 g/kWh, which is within the tolerance limit of IS: 12207-2014.

#### 7.2.1.2 Power take off shaft :

i) The PTO master shield is not provided .This should be looked into for safety point of view on the tractor.

# 7.2.1.3 Three point linkage:

i)

The lateral distance of the lower hitch point from the center line of the tractor not meet the requirements of IS 4468 (Part 1) 1998.

## 7.3 Recommendation with regard to safety on tractor:

The following requirements, inter alia, may be considered for incorporation on the tractor:

- i) The inclination towards rear direction is less and no vertical adjustment for the operator's seat is provided.
- ii) The provision of the safety start switch for the engine and the engine STOP knob.
- ii) Provision for spark arresting device in exhaust system.
