#### 1. SCOPE OF TEST

The "Mahindra 215 (Brand Name: Yuvraj 215)" had undergone "Confidential test "at this institute having test report no. T- 721/1228/2010 released in May, 2010 .Later, on the request of the applicant via letter no. Nil dated 30.7.2010 test report converted from confidential to the Initial Commercial Test" at this Institute and the test report No. T- 721/1228/2010 released in May, 2010 was treated as Initial Commercial Test report. Now the applicant has submitted an application vide letter No. Nil dated 27.11. 2012 for testing of "Mahindra 215+ (Brand Name: Yuvraj 215) Tractor" as a Variant of "Mahindra 215 (Brand Name: Yuvraj 215) Tractor".

The applicant having enclosed a list of following differences in the technical specifications between "Mahindra 215 (Brand Name: Yuvraj 215)" and "Mahindra 215+ (Brand Name: Yuvraj 215) Tractor" and requested to test the "Mahindra 215+ (Brand Name: Yuvraj 215) Tractor" as a variant of "Mahindra 215 (Brand Name: Yuvraj 215) Tractor.

On the basis of test conducted the performance results have been summarized as evaluative (mandatory) and non - evaluative (not mandatory) parameters applicable for qualifying Minimum Performance Criteria as per clause-4 table-1 of Indian Standard 12207: 2008 for acceptance of tractor for the purpose of subsidies/NABARD financing for the applicable features for this tractor model.

- 7.2 Salient Observations:
- 7.2.1 Laboratory tests:
- PTO Performance: 7.2.1.1
  - i) The specific fuel consumption in case of base and variant models corresponding to maximum power were observed as 280 & 277 g/kWh respectively against the declaration of 280 g/kWh, which is within the tolerance limit.
  - The maximum PTO power in case of base and variant models were observed as 8.9 & 8.8 kW respectively against the declaration of 9.04 kW which is within the specified limit.

#### Specifications of Power Take Off Shaft:

Dimension "Ao" of PTO shaft does not meet to requirement of IS 4931:1995. This should be looked into for compliance.

#### Operator's seat (Conformity with IS: 12343-1998): 7.2.1.3

The operator's seat provided on the tractor does not meet the following requirements and calls necessary improvement.

- Length & Width of seat
- Longitudinal distance from seat index point to the centre of steering control wheel.
- iii) Provision for adjustment of the driver's mass

#### Operator's work place: IS:12239 (Part-I& II)

The operator's work place provided on the tractor does not meet the following requirements and calls necessary improvement.

- Silencer is not fully protected.
- Hydraulic pipe lines are not insulated properly.
- iii) Width of foot Step is lees .
- iv) Provision of PTO master shield is not provided.
- v) Spark arrester not provided at the exhaust location.
- Vertical retainers have not been provided on both sides of clutch & brake pedals

## Location and operation of operator's control:

Operations of some of the operator's control do not meet the requirements of IS: 8133-1983 like the safety starting switch. This may be looked into for necessary corrective action.

#### Labelling of tractor: - Meets the requirements 7.2.1.6

#### Maintenance / Service Problems: 7.3

No noticeable maintenance or service problem was observed during the test. However, suitable provision for draining the water may be provided at the fuel tank.

#### Recommendation with regard to safety on tractor: 7.4

The following requirements, inter alia, may be considered for incorporation on the tractor:

- Safety provision against accidental start of engine. i)
- ii) Proper insulation at hydraulic pipes may be provided
- iii) Silencer is should be fully guarded to protect the operator from injury.
- Width of foot step should be enough to safe step up on the tractor.
- The working clearance around Draft control lever may be provided as per the requirements of Indian Standard: 12239 (Part-2) - 1999.
