
#: The testing fee will be revised on the first day of Fiscal year biannually @ 8% (i.e. the testing fee will be revised @ 8% w.e.f: 01.04.2024 and 2<sup>nd</sup> revision will be held w.e.f. 01.04.2026 and so on).

\*If the manufacturer wishes to conduct the running-in at CFMTTI, Budni, the same will be charged separately as per the above applicable rates of testing fee.

The above testing charges are exclusive of GST, if GST applicable the same will be charged separately.

The above testing charges are for Initial Commercial Test (ICT)/ Batch testing/variant testing of tractor as applicable.
